• You can cancel your participation 45 days before the beginning of the fair. If you cancel between 30 and 45 days before the event you must pay 60% of your total invoice. If you cancel 30 days before the fair you must pay 100% of your total invoice. Participation at the fair is possible only after 100% payment in advance.

In case of dispute is competent Commercial Court in Belgrade.

• The prices of services that depend on the prices set by suppliers (electricity, internet and telephone services, water...) change depending on the change in purchase prices. The organizer has the right to correct prices according to changes in purchase prices.

• The organizer has the right to move the exhibitor's exhibition space to a similar position, according to the change in the concept of the exhibition space in the hall, and is not obliged to inform the exhibitor about it.

• The organizer has the right to change the location where the fair will be held and the date of the fair.
